Answer: No. The March quarter included the completion of legacy loss-making projects, trading of businesses that have been disposed, greater than usual creditor payments and costs associated with the Company's restructure.

Answer: No. The Company has sufficient cash to meet its expected commitments.

Answer: Yes. The Company has improved its cash position as a result of the transformational activities undertaken, secured new contracts and significantly lowered its cost base.
