Rights Issue - Extension of Closing Date

Applications and payment **must now be received by 5pm (AEST) on Friday 29 May 2020.** The issue date for New Shares subscribed for under the Rights Issue will now be on Friday, 5 June 2020, with quotation of new Shares and despatch of holding statements expected to take place on or around Tuesday 9 June, 2020.
