

NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001

Mithril Resources Limited (ASX: MTH) (**Company**) gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) in compliance with the requirements of section 708A(6) of the Corporations Act as follows:

- (a) The Company has today issued an aggregate of 763,912,231 fully paid ordinary shares. 673,852,281 shares were issued as consideration for the Company acquiring all the issued capital of Sun Minerals Pty Ltd (**Transaction**), 10,000,000 shares were issued in connection with the Transaction and 80,059,950 shares were issued at \$0.005 per share under the shortfall of the recent rights issue of the Company.
- (b) The shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- (c) As at the date of this notice to Company has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) section 674 of the Corporations Act.
