Key terms of Share Rights granted under the Employee Equity Plan

The Commonwealth Bank of Australia (**Company**) operates deferred employee equity plans which align senior employees' interests to shareholders, and aim to motivate and reward employees.

Key terms of Share Rights granted to employees under the Employee Equity Plan (**EEP**) as set out in the Appendix 3G are as follows.

Eligibility	An employee of the Group or as determined by the Board. Awards of the type set out in the Appendix 3G are generally limited to the Group's key management personnel, and a limited number of senior employees in our London Branch who receive Share Rights in compliance with local regulations.
Instrument	Each right is an entitlement to receive one fully-paid ordinary share in the Company, or a cash equivalent payment, subject to meeting vesting conditions as determined by the Board (Share Right). Share Rights are granted to participants at no cost.
Vesting period	Defined period set out at time of grant.
Vesting conditions	Vesting of Share Rights is subject to the satisfaction of vesting conditions, which may include performance measures and will generally be subject to continuous employment with the Group and a risk review.
Exercise	Share Rights are automatically exercised after the vesting conditions have been met and the award is no longer subject to any restrictions. Participants are not required to pay any amount upon automatic exercise of their vested Share Rights.
Cessation of employment	The Board has discretion under the Rules of the EEP to vest or lapse some or all of a participant's Share Rights on cessation of employment. The Board specifies in the offer to a participant how Share Rights are treated on cessation of employment. In general, unless otherwise determined by the Board, participants who resign or are dismissed before the end of the vesting period will forfeit all unvested Share Rights. Where a participant's exit is related to any other reason (e.g., retrenchment, retirement or death), any unvested Share Rights will continue on-foot subject to the terms and conditions of the award.

Dividends and voting rights	No dividends, dividend equivalent payments or voting rights are provided on unvested Share Rights.
