Brambles Limited: Appendix 2A

Please find attached an Appendix 2A relating to 1,107 ordinary shares in Brambles Limited which have been issued as a consequence of the exercise of share awards under the Brambles Limited MyShare Plan to former employees classified as “good leavers” under that plan. (Please note that 1,293 unlisted matched share rights granted under the Brambles Limited MyShare Plan have lapsed since the lodgement by Brambles of the Appendix 2A on 9 June 2020.)
