We refer to the substantial holder notice lodged on 23 December 2019 which was issued in connection with an $\frac{1}{2}$

 $application\ brought\ by\ Cromwell\ Property\ Group\ to\ the\ Take overs\ Panel,\ which\ subsequently\ declined\ to\ conduct$

proceedings.

Since the December notice, members of the Tang family and related entities have made various acquisitions and

disposals of securities in Cromwell Property Group, resulting in a net increase in those parties' aggregate holdings

from 13.67% to 16.60%.
