MARKET COMMENTARY

Australia's share market extended its gains for a third consecutive month with the S&P/ASX200 Accumulation Index rising +2.6% in June. Shares opened the month posting sharp gains with investor optimism fuelled by a continued commitment to accommodative monetary policy and ongoing fiscal stimulus measures worldwide. The rally faltered mid-month with a sell-off sparked by US Federal Reserve Chairman Jerome Powell's dour outlook comments and a resurgence in coronavirus cases. However, the correction proved short-lived and, despite a steady stream of negative economic and employment data, markets proved resilient.

The Australian share market finished an extraordinary and volatile financial year down -7.7%. Entering the new financial year, the global economic outlook remains subdued with a number of countries battling to contain the coronavirus pandemic. However, with investor optimism buoyed by unprecedented stimulus measures, equity markets have largely diverged from economic fundamentals.


