SciDev Completes AUD\$5m Placement, Appendix 2A and Cleansing Statement

SciDev Limited (ASX: SDV) ('SciDev' or the 'Company') is pleased to advise that it has completed the A\$5m placement announced on 16 July 2020, with the issue of 7,692,308 new shares at an issue price of \$0.65c per share. The Placement was taken up in full by two leading Australian Fund Managers, one being Perennial Value Management and the second is a long only Fund.
