On 27 September 2019, Magnis announced that it had secured a \$8 million investment through the issue of fully paid ordinary shares to Middle East based Negma Group Limited. Negma will provide up to \$8 million over a 12-month period with a maximum monthly subscription of \$700,000. The price of the shares issued will be at an 8% discount to the previous ten day Volume Weighted Average Price ('VWAP'). The Company has the flexibility to call the monthly amounts and can cancel the agreement at any stage. A commitment fee of 5% of the maximum committed capital equal to \$400,000 is payable via the issue of fully paid ordinary shares at \$100,000 per month for the first four months of the overall subscription. In addition, the Company issued 4,000,000 Unlisted Options in the Company at an exercise price of \$0.40 per share with an expiry date of 30 April 2021 subject to shareholder approval.
