#### APPENDIX 3X AND APPENDIX 3Z LATE LODGEMENT

The Company is in receipt of a query from the ASX dated 3 August 2020 concerning the late lodgement of the Appendix 3Z by Mr Tim Monger and the Appendix 3X by Mr Andrew Bristow which are enclosed.

Addressing the issues raised, the Company notes:

- 1. The Appendices 3X and 3Z were lodged late due to a series of board changes including the transition of the Company Secretary role, which occurred simultaneously as announced and as a result of a material transaction which led to an oversight of the required appendices not being lodged;
- 2. Directors are aware of their obligations under Listing Rule 3.19A. Upon appointment with the Company, directors are obligated to acknowledge this obligation in the formal letter of appointment and have done so in accordance with the Listing Rules;
- 3. The Company intends to reinforce the obligation for directors to disclose their interests ensuring compliance with Listing Rule 3.19B and the recently announced Board and management changes will assist with this.
