### **Request for Trading Halt – Sydney Airport (ASX:SYD)**

Sydney Airport Limited (ACN 165 056 360) and The Trust Company (Sydney Airport) Limited (ACN 115 967 087) as responsible entity for Sydney Airport Trust 1 (ARSN 099 597 921) (together, **Sydney Airport**) requests a back-to-back trading halt for up to three consecutive days in its stapled securities (ASX Code: SYD) pursuant to Listing Rule 17.1, from the commencement of trading today.

For the purposes of Listing Rule 17.1, Sydney Airport provides the following information:

- 1 Sydney Airport is seeking the trading halt pending an announcement in relation to a capital raising comprising an underwritten pro rata accelerated renounceable entitlement offer (with retail rights trading) (the **Offer**);
- 2 Sydney Airport requests that the trading halt remain in place until the earlier of making of an announcement to the market regarding the outcome of the institutional component of the Offer and the commencement of trading on Friday, 14 August 2020; and
- 3 Sydney Airport is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.
