### Financial Statements and Reports

The Corporations Act requires the Directors to present to the AGM the Financial Report, the Directors' Report, and the Auditor's Report for the last financial year ending before the AGM. Apart from the matters involving remuneration, which are required to be voted upon, neither the Corporations Act nor the Company's Constitution requires a vote of shareholders at the AGM on such reports or statements.

In accordance with section 250S of the Corporations Act, shareholders will be given a reasonable opportunity to ask questions about, and make comments on, the management of the Company.

In addition to asking questions at the AGM, shareholders may address written questions to the Company's auditor which are relevant to:

- (a) the content of the Auditor's Report to be considered at the AGM; or
- (b) the conduct of the audit of the Financial Report to be considered at the AGM.

# Item I - Remuneration Report

In accordance with section 250R of the Corporations Act the Company must put to a vote a resolution that the Remuneration Report be adopted. The Remuneration Report forms part of the Directors' Report contained in the Annual Report.

#### Voting exclusion statement

Under the Corporations Act, voting restrictions apply to the Company's Key Management Personnel ("KMP") and their closely related parties for this resolution. The term "closely related parties" in relation to a member of KMP includes a spouse, dependent and certain other close family members, as well as companies controlled by the KMP. The Chairman intends to vote any proxies held by him in favour of this resolution (unless specifically directed otherwise).

The Company will disregard any votes cast on Item 1 by, or on behalf of;

- a member of the KMP whose remuneration is disclosed in the Remuneration Report (and their closely related parties) in any capacity; and
- a member of the KMP at the date of the AGM (and their closely related parties) acting as proxy.

Unless the vote is cast:

- as a proxy for a person entitled to vote in accordance with a direction on the proxy form, or
- by the Chairman of the AGM as proxy for a person entitled to vote and the Chairman has received express authority to vote
  undirected proxies as the Chairman sees fit.

The vote on this resolution is advisory only and does not bind the Directors or the Company; however, the Directors may take into future consideration the shareholders' vote on this matter. A reasonable opportunity will be provided to shareholders to ask questions or make comments on the Remuneration Report at the AGM.



# Item 2 - Re-election of Mr David Baffsky AO as a Director

Mr Baffsky AO was appointed as a Director of Ariadne on 18 March 2008 and Chairman of the Board on 13 January 2009. He retires by rotation in accordance with Rule 19 of the Company's Constitution and, being eligible, offers himself for re-election.

Mr Baffsky holds a law degree from the University of Sydney and was the founder, and until 1991, the senior partner of a Sydney legal firm specialising in commercial and fiscal law. Mr Baffsky is Honorary Chairman (formerly Executive Chairman between 1993 and 2008) of Accor Asia Pacific, which is the largest hotel management company in the Asia Pacific region. He is Chairman of Investa Property Group and a board member of Destination NSW.

Amongst previous roles, Mr Baffsky was a director of The George Institute, The Australian Brandenburg Orchestra and a board member of Sydney Olympic Park Authority. He was a Director of SATS Limited, Chairman of Food & Allied Support Services Corporation Ltd, a Trustee of the Art Gallery of NSW, Chairman of Voyages Indigenous Tourism Ltd and a Director of the Indigenous Land Corporation. He was a member of the Business Government Advisory Group on National Security and a member of the Federal Government's Northern Australia Land and Water Taskforce.

In 2001 Mr Baffsky was made an Officer in the General Division of the Order of Australia and in 2003 he received the Centenary Medal. In 2004 he was recognised as the Asia Pacific Hotelier of the Year. In 2012 he was awarded the Chevalier in the Order of National Légion d'Honneur of France.

Mr Baffsky was appointed to the Ariadne Audit and Risk Management Committee on 18 March 2008.

All other Directors believe that Mr Baffsky, an independent director, makes a valuable contribution to the Company and recommend that shareholders vote in favour of the re-election of Mr Baffsky as a Director.

# Item 3 - Re-election of Mr John Murphy as a Director

Mr Murphy was appointed as a Director of Ariadne on 6 December 2006. He retires by rotation in accordance with Rule 19 of the Company's Constitution and, being eligible, offers himself for re-election.

Mr Murphy was a partner in international accounting firm Arthur Andersen where he specialised in merger and acquisition and insolvency and reconstruction. He held management positions in that firm at the Australian, regional and global level. He has also spent twenty years as the founder and managing director of various private equity funds including Investec Wentworth Private Equity Limited and Adexum Capital limited. He was a Director of Investec Bank Australia Limited from 2004 until 2013.

Mr Murphy has extensive public company experience having been a Director of listed companies Southcorp Limited, Specialty Fashion Group Limited, Vocus Communications Limited, Gale Pacific Limited, Redflex Limited, and Australian Pharmaceutical Industries Limited.

Mr Murphy was appointed to the Ariadne Audit and Risk Management Committee on 6 December 2006 and was elected Committee Chairman on 18 March 2008.

All other Directors believe that Mr Murphy, an independent director makes a valuable contribution to the Company and recommend that shareholders vote in favour of the re-election of Mr Murphy as a Director.

#### Item 4 – Appointment of Grant Thornton Audit Pty Ltd as Auditor of the Company

As part of the Board's commitment to good corporate governance and the effective operation of the business, the Audit Committee conducted a review of the current audit appointment together with alternative audit service providers. Following a tender process, including a detailed review and assessment of the capabilities of alternate firms, the Audit Committee recommended to the Board, and the Board has proposed that Grant Thornton Audit Pty Ltd ("Grant Thornton") be appointed as the Company's Auditor. If Grant Thornton are appointed as Auditor, arrangements are in place between Ariadne, Deloitte Touche Tohmatsu and Grant Thornton to ensure a smooth transition between audit firms.

Deloitte Touche Tohmatsu will request the consent of the Australian Securities and Investments Commission ("ASIC") to resign as the Company's Auditor with effect from the close of this AGM. Subject to ASIC consenting to the resignation of Deloitte Touche Tohmatsu and shareholders' approval and having received Grant Thornton's prior written consent, it is proposed Grant Thornton be appointed the Company's Auditor. A copy of the nomination of Grant Thornton's as Auditor of the Company is set out in Annexure A hereto.

If this resolution is passed, the appointment of Grant Thornton as the Company's Auditor will take effect at the close of this Meeting.

The Directors of Ariadne recommend that shareholders vote in favour of the proposed resolution.
