NTA & Fund Update – 31 August 2020

NTA Update

The estimated unaudited net tangible asset (NTA) value after tax as at 31 August 2020 was \$1.72^{1,2} per unit (31 July 2020 was \$1.78² per unit).

Between 31 July 2020 and 31 August 2020, the majority of the change in the estimated unaudited NTA can be attributed to foreign exchange movements. During this period, the Australian dollar appreciated against the US dollar by 3.26% to 0.7376 (from 0.7143 in July 2020).

Fund Update

Capital called

At 31 August 2020, US Select Private Opportunities Fund III L.P. (**LP**) has called US\$88.5 million (or 77.6% of capital committed). The Fund's proportionate share is approximately US\$63.0 million (a 71.2% share).
