SHARE PURCHASE PLAN – LETTER TO ELIGIBLE SHAREHOLDERS

We write to you as the holder of Nearmap Ltd (ASX: NEA) (**Nearmap** or **Company**) fully paid ordinary shares (**Shares**) with a registered address in Australia or New Zealand as at the record date of 7:00pm (Sydney time) Wednesday, 9 September 2020 (**Record Date**).

On behalf of the Directors, I am pleased to offer you the opportunity to participate in the Nearmap share purchase plan (**SPP**), which was announced to the Australian Securities Exchange (**ASX**) on 10 September 2020 and follows shortly after the successful placement of shares to sophisticated, professional and institutional investors which raised A\$72.1 million (**Placement**).

In our 10 September 2020 ASX announcement, we outlined that our decision to raise capital was to support our strategy to accelerate growth opportunities in our core growth verticals, invest into our next generation camera system roll-out, invest in operational systems and data, and to provide strategic flexibility to pursue growth opportunities. We believe this will create long term value for all our shareholders.

Nearmap is undertaking the SPP offer to shareholders of the Company with a registered address in Australia or New Zealand as at 7:00pm on the Record Date. The Issue Price per Share to be issued under the SPP (**SPP Shares**) will be the lower of:

- A\$2.77, being the price at which Shares were issued to investors under the Company's recent Placement, representing a 4.2% discount to the closing price of \$2.89 on 9 September 2020; and
- a 2.5% discount to the volume weighted average price of Shares traded on ASX during the 5 trading days up to and including the SPP Closing Date (Tuesday, 29 September 2020 to Monday, 5 October 2020).

This means the maximum price will be A\$2.77 per SPP Share.

The SPP will allow Eligible Shareholders to apply for up to A\$30,000 worth of SPP Shares at the Issue Price.

An offer booklet in relation to the SPP was lodged with the ASX today (**Offer Booklet**). A copy of the Offer Booklet along with your personalised Application Form about how to apply for the SPP and submit a

AVAILABILITY OF THE SHARE PURCHASE PLAN

The SPP is available to all Eligible Shareholders to apply for a minimum of A\$1,000 and a maximum of A\$30,000, worth of Shares, in the increments set out in section 5(a) of the SPP Terms and Conditions in our Offer Booklet, at an issue price per Share which is the lower of:

- A\$2.77, being the price at which Shares were issued to investors under the Company's recent Placement, representing a 4.2% discount to the closing price of \$2.89 on 9 September 2020; and
- a 2.5% discount to the volume weighted average price of Shares traded on ASX during the 5 trading days up to and including the SPP Closing Date (Tuesday, 29 September 2020 to Monday, 5 October 2020).

Funds must be received by the Company on or before 5:00pm (Sydney time) **Monday, 5 October 2020**, unless the Company extends the Closing Date of the SPP, in which case an announcement will be made to the ASX.

Eligible Shareholders may participate in the SPP by:

- making a payment by direct transfer, if you are an Eligible Shareholder with a registered address in New Zealand,



in accordance with the instructions shown on <u>www.spp-nearmap.com.au</u> and outlined in the Offer Booklet, and using the personalised customer reference number which is required to identify your holding as shown on your personalised Application Form (available at <u>www.spp-nearmap.com.au</u>).

Applications for SPP Shares can only be made by Eligible Shareholders. Nearmap reserves the right to close the SPP early or extend the SPP in its discretion. Participation is optional and Eligible Shareholders may elect to do nothing. If you choose to do nothing, you will continue to hold the same number of Shares, however, your interest in Nearmap will be diluted. Your right to participate in the SPP is not transferable.

SCALE BACK

The SPP aims to raise approximately A\$20 million. Nearmap may decide to accept applications (in whole or in part) that result in the SPP raising more or less than this amount in its absolute discretion. In the event of a scale back occurring, Nearmap reserves the right to give priority to Eligible Shareholders in any manner it sees fit, including taking into account the size of your shareholding as at the Record Date. Any decisions made by Nearmap will be final.

If a scale back produces a fractional number of SPP Shares when applied to the number of Shares for which you have applied, the number of SPP Shares issued to you will be rounded down to the nearest whole number of SPP Shares.

If there is a scale back, the difference between the Application Monies received from you, and the number of SPP Shares allocated to you multiplied by the Issue Price, will be refunded to you in full without interest.

NEARMAP LTD - SHARE PURCHASE PLAN

On 11 September 2020, Nearmap Ltd (**Nearmap** or **Company**) announced to the Australian Securities Exchange (**ASX**) that it had successfully raised A\$72.1 million from an institutional placement of ~26.0 million new fully paid ordinary shares in Nearmap (**Shares**) to investors at an issue price of A\$2.77 per Share (**Placement**), representing a discount of 4.2% to Nearmap's closing Share price on ASX on Wednesday, 9 September 2020.

The Board of Directors of Nearmap (**Board**) recognises that a number of Nearmap's loyal shareholders did not have an opportunity to participate in the Placement. The Board is therefore pleased to offer Eligible Shareholders (as defined below) an opportunity to participate in Nearmap's share purchase plan (**SPP**). The SPP will give all Eligible Shareholders the opportunity to apply for up to A\$30,000 worth of new Shares. The Shares will be priced at the lower of:

- A\$2.77, being the price at which Shares were issued under the Placement, being a 4.2% discount to the closing price of A\$2.89 on 9 September 2020; and
- a 2.5% discount to the volume weighted average price (VWAP) of Nearmap Shares traded on the ASX during the five trading days up to and including the Closing Date (Tuesday, 29 September 2020 to Monday, 5 October 2020).

The capital raised under the Placement and the SPP will be used to accelerate growth opportunities, including:

- deeper penetration into strategic core growth verticals through:
 - o scaling investment in Sales & Marketing, particularly in North America; and
 - expanding product solutions to high-value use cases, providing greater engagement and utility to customers;
- acceleration of the roll-out of HyperCamera3 (HC3) systems, generating extended coverage at higher fidelity and enabling expansion into new geographical markets; and
- investment in operational systems and data to support rapid scaling.

The capital raising also provides strategic flexibility to pursue other growth initiatives and respond to opportunities in a dynamic market.

The SPP is open to all shareholders recorded as holding Shares on Nearmap's Register as at 7.00pm (Sydney time) on Wednesday, 9 September 2020 (**Record Date**) with a registered address in Australia or New Zealand (and who otherwise meet certain other conditions as set out in the attached SPP Terms and Conditions) (**Eligible Shareholders**).

Other conditions of the SPP include:



- certificates (in the case of 'custodians') and full payment for Shares subscribed for under the SPP must be received by 5.00pm (Sydney time) on Monday, 5 October 2020 in accordance with the instructions set out in the Application Form and the SPP Terms and Conditions; and
- the SPP aims to raise approximately A\$20 million. The following are the terms and conditions of the Offer. By accepting the Offer, you agree to be bound by these SPP Terms and Conditions.

1. The Offer

- (a) Nearmap offers each Eligible Shareholder (as defined below) the opportunity to purchase up to \$30,000 worth of Shares under the SPP subject to and in accordance with these SPP Terms and Conditions (the **Offer**).
- (b) The Offer opens at 9:00am (Sydney time) on Thursday, 17 September 2020 (**Opening Date**) and closes at 5:00pm (Sydney time) on Monday, 5 October 2020 (**Closing Date**).
- (c) Nearmap reserves the right, subject to the Corporations Act and the ASX Listing Rules, to vary the Closing Date without prior notice. If the Closing Date is varied, subsequent dates may also be varied accordingly.
- (d) The Offer to each Eligible Shareholder (including Custodians) is made on the same terms and conditions.
- (e) The Offer is entirely voluntary. You are not obliged to participate in the Offer.
- (f) Once the Shares are issued, they will rank equally with existing Shares and will carry the same voting rights, dividend rights and other entitlements.
- (g) All references to \$ or dollars in this Booklet are reference to Australian dollars unless otherwise indicated.

2. Eligible Shareholders

- (a) You are eligible to apply for Shares under the Offer if:

- (b) Nearmap will announce the Issue Price for the SPP after the SPP closes.
- (c) By applying for Shares, you agree to pay the Issue Price per Share for the number of Shares calculated under Section 5(b) or, if there is a scale back the number of Shares calculated under Section 10.
- (d) The current Share price can be obtained from the ASX at www.asx.com.au.

5. Applications for Shares

- (a) Eligible Shareholders may subscribe for a minimum of \$1,000 and a maximum of \$30,000 worth of Shares in the following increments:
 - (i) \$1,000;
 - (ii) \$2,500;
 - (iii) \$5,000;
 - (iv) \$10,000;
 - (v) \$15,000;
 - (vi) \$20,000;
 - (vii) \$25,000; and
 - (viii) \$30,000.
- (b) If your application is accepted, Nearmap will divide the value of your Application Monies by the Issue Price (as determined in accordance with Section 4(a)) in order to determine the number of Shares which, subject to scale back, will be issued to you.
- (c) If this calculation produces a fractional number, the number of Shares issued to you will be rounded down to the nearest whole number of Shares.



- (d) Eligible Shareholders who receive more than one offer under the SPP (for example, because they hold Shares in more than one capacity or in different registered holdings) may apply for Shares under their various capacities but may not apply for Shares with an aggregate value of more than \$30,000.

If you make a payment by BPAY[®] or direct transfer (as applicable), you are taken to make the certifications, representations and warranties described in these SPP Terms and Conditions. Custodians applying for Eligible Beneficiaries must still complete and return a Custodian Certificate.

Please note that your financial institution may apply limits on the use of your BPAY[®] or direct transfers (as applicable) and that you should make enquiry about the limits that apply in your personal circumstances.

- (b) The Share Registry will send to you a holding statement in due course following the Issue Date. You should confirm your holding before trading in any Shares you believe have been allocated to you under the SPP.

8. Discretion regarding applications

(a) Nearmap may accept or reject applications to purchase Shares under the Offer, including (but not limited to) cases where:



- an Application Form (or a Custodian Certificate, in the case of Custodians) is incorrectly completed, incomplete or otherwise determined by Nearmap to be invalid;
- (ii) a BPAY[®] or direct transfer payment is not received, or is incomplete or invalid;
- (iii) an applicant appears to be applying for more than \$30,000 worth of Shares (in aggregate);
- (iv) a BPAY® or direct transfer payment, an Application Form or (in the case of Custodians) a custodian Certificate, is received after the Closing Date. While Nearmap has discretion to accept late Application Forms, BPAY® payments, direct transfer payments and Custodian Certificates, there is no assurance that it will do so. Late BPAY® or direct transfer payments, Application Forms and Custodian Certificates, if not processed, will be returned to you at your registered address or refunded;
- (v) Nearmap considers, or is reasonably satisfied, that the application (whether alone or in conjunction with other applications) does not comply with the requirements of ASIC Instrument 19/547; or
- (vi) Nearmap believes an applicant is not an Eligible Shareholder or Custodian acting on behalf of an Eligible Beneficiary (subject to compliance with any applicable ASIC or ASX requirements);

- (d) agree that your application is only effective when Nearmap receives cleared funds by BPAY® or direct transfer (as applicable);
- (e) warrant that you are an Eligible Shareholder and are eligible to lawfully participate in the SPP and apply for Shares, in each case in accordance with these terms and conditions as well as any applicable laws;
- (f) acknowledge that no interest will be paid on any Application Monies held pending the issue of Shares or subsequently refunded to you for any reason;
- acknowledge that Nearmap and its officers and agents are not liable for any consequences on the exercise or non-exercise of its discretions referred to in these SPP Terms and Conditions;
- (h) agree to pay the Issue Price per Share up to the maximum value of your BPAY[®] or direct transfer payment (as applicable);
- (i) acknowledge and agree that:
 - (i) you are not in the United States and are not acting for the account or benefit of a person in the United States;
 - (ii) the Shares have not been, and will not be registered under the Securities Act or the securities laws of any state or other jurisdiction of the United States, and accordingly the Shares may not be offered, sold or otherwise transferred in the United States except in a transaction exempt from, or not subject to, the registration requirements of the Securities Act and the applicable securities laws of any state or other jurisdiction in the United States;
 - (iii) you have not, and will not, send this Booklet or any materials relating to the SPP to any person in the United States or to any person located in any other country outside Australia and New Zealand; and
 - (iv) if you are acting as a trustee, nominee or Custodian, each beneficial holder on whose behalf you are participating is resident in Australia or New Zealand, and you have not sent this Booklet, or any materials relating to the SPP, to any person outside Australia and New Zealand;



- (j) If you are applying on your own behalf (and not as a Custodian), acknowledge and agree that:
 - you are not applying for more than \$30,000 worth of Shares under the SPP (including by instructing a Custodian to acquire Shares on your behalf under the SPP);
 - (ii) the total of the application price for the following does not exceed \$30,000 (irrespective of whether you may have received more than one Offer or received Offers in more than one capacity):
 - (A) the Shares the subject of your application under the Offer;

 - (i) you are a Custodian (as that term is defined in ASIC Instrument 19/547);
 - (ii) you hold Shares on behalf of the Eligible Beneficiary as at the Record Date who has instructed you to apply for Shares on their behalf under the SPP and that that Eligible Beneficiary has been given a copy of this Booklet;
 - (iii) you are not applying for Shares on behalf of any Eligible Beneficiary with an application price of more than \$30,000 under the SPP;
 - (iv) your application will not be accepted unless you duly complete and submit a Custodian Certificate in accordance with Section 5(e);
 - (v) the information in the Custodian Certificate submitted by you is true, correct and not misleading;
- (I) accept the risk associated with any refund that may be dispatched to you by direct credit or cheque to your address shown on the Register;
- (m) are responsible for any dishonour fees or other costs Nearmap may incur in relation to issuing a cheque for any refund that may be dispatched to you and which is dishonoured;
- (n) agree to be bound by the constitution of Nearmap (as amended and as it may be amended from time to time in the future);
- (o) acknowledge that neither Nearmap nor its officers, advisers or agents, has provided you with any financial product or investment advice or taxation advice in relation to the SPP, or has any obligation to provide such advice;



- (p) acknowledge that the market price of Shares may rise or fall between the date of the Offer and the Issue Date and that the Issue Price you pay for Shares may exceed the market price of Shares on the Issue Date;
- (q) acknowledge that there are risks associated with acquiring and holding Shares;
- (r) acknowledge that Nearmap may at any time irrevocably determine that your application is valid, in accordance with the terms and conditions of the SPP, even if the Application Form is incomplete, contains errors or is otherwise defective; and
- (s) authorise Nearmap, and its officers and agents, to correct minor or easily rectified errors in, or omissions from, your Application Form and to complete the Application Form by the insertion of any missing minor detail.

10. Applications may be scaled back

- (a) The SPP aims to raise approximately \$20 million. Nearmap may decide to accept applications (in whole or in part) that result in the SPP raising more or less than this amount in its absolute discretion. In the event of a scale back occurring, Nearmap reserves the right to give priority to Eligible Shareholders in any manner it sees fit, including taking into account the size of your shareholding as at the Record Date. - (b) If there is a scale back, you may not receive all the Shares for which you have applied. If a scale back produces a fractional number when applied to the number of Shares for which you have applied, the number of Shares issued to you will be rounded down to the nearest whole number of Shares.
- (c) If there is a scale back, the difference between the Application Monies received from you, and the number of Shares issued to you multiplied by the Issue Price, will be refunded to you in full without interest.

11. ASIC relief

- (a) The offer of Shares under the SPP is made in accordance with ASIC Instrument 19/547, which grants relief from the requirement to prepare a disclosure document for the SPP subject to certain requirements.
- (b) Nearmap has, prior to the release of this Booklet, given a notice to ASX that complies with the requirements of ASIC Instrument 19/547.

12. Variation and termination

- (a) Nearmap reserves the right at any time to:
 - (i) amend or vary these SPP Terms and Conditions;
 - (ii) waive strict compliance with any provision of these SPP Terms and Conditions;
 - (iii) withdraw the SPP or suspend or terminate the SPP;
 - (iv) vary the timetable for the SPP, including, without limitation, the Closing Date; and
 - (v) not accept an application, not issue Shares, or issue Shares to a value less than that applied for under the SPP by an Eligible Shareholder (including a Custodian applying on behalf of one or more Eligible Beneficiaries).



- (b) Any such amendment, variation, waiver, suspension, withdrawal, non-acceptance or termination will be binding on all Eligible Shareholders and Custodians even where Nearmap does not notify you of that event.
- (c) In the event that the SPP is withdrawn or terminated, all Application Monies will be refunded. No interest will be paid on any money returned to you.

13. Underwriting

The Offer is not underwritten.

14. Transaction Costs

The only cost associated with the Offer is the Issue Price for the number of Shares for which you wish to subscribe. You do not have to pay for brokerage, commission or other transaction costs which would normally apply when you acquire Shares on market.

15. Directors' Participation

Directors who are Eligible Shareholders may (without having to obtain prior Shareholder approval), participate in the Offer, on the same terms as all other Eligible Shareholders.

16. Dispute resolution

- (a) Nearmap may settle any dispute in connection with the Offer in any manner it thinks fit, whether generally or in relation to any participant, application or Share. Nearmap's decision will be final and binding.
- (b) Nearmap reserves its right to waive strict compliance with any provision of the SPP Terms and Conditions.

17. Privacy

- (a) The Application Form requires you to provide personal information.
- (b) Chapter 2C of the Corporations Act requires information about a shareholder (including your name, address and details of the securities you hold) to be included in the register of the entity in which you hold securities. This information must continue to be included in the register if you cease to be a shareholder.
- (c) By receiving completed Application Forms, Nearmap and its service providers such as the Share Registry may collect, hold and use your information to assess your application, provide services to you as an investor and for other permitted purposes under the *Privacy Act 1988* (Cth).
- (d) Your information may be disclosed to your financial adviser and to Nearmap's agents and service providers on the basis that they deal with such information in accordance with the privacy policy of Nearmap which can be accessed at <u>http://www.nearmap.com.au/legal/privacy</u>.

18. Governing law and jurisdiction

These SPP Terms and Conditions are governed by the laws in force in New South Wales, Australia. Any dispute arising out of or in connection with the SPP Terms and Conditions, or the Offer, will be determined by the courts of New South Wales. By accepting the Offer, you agree to submit to the non-exclusive jurisdiction of the courts of New South Wales.
