Orders Successfully Obtained

THC Global Group Limited (**THC Global** or the **Company**) (ASX:THC) refers to its announcement on 21 September 2020 advising that the Company was to lodge a Cleansing Prospectus with the Australian Securities and Investments Commission (**ASIC**) and seek orders from the Federal Court of Australia with respect to a placement conducted by the Company in June 2020 (the **June 2020 Placement**).

Following becoming aware of this matter, the Company was able to act quickly to ensure that a Cleansing Prospectus was lodged with ASIC and an application was made to the Federal Court of Australia to be heard on an urgent expedited basis.

The Company is now pleased to confirm that the matter was heard in the Federal Court of Australia earlier today, and the Company has obtained the orders requested by the Company.

With these Orders now successfully obtained, the Company will request that the ASX lift the trading halt in the Company's securities immediately, and for trading to recommence as normal.
