**10 HOLES RC DRILLING PROGRAM COMPLETED AT STIRLING VALE
EL8747 COBALT-ZINC-GOLD EXPLORATION, BROKEN HILL NSW**

Ausmon Resources Limited (“Company”) is pleased to advise that the 10 holes RC drilling program has been finalised yesterday at the Stirling Vale prospect in EL 8747, Broken Hill NSW. The heavy rain and flooding during the last weekend in Broken Hill areas has delayed the drilling of the 10th hole by about 3 days.

Some of the preliminary indications for base metals, copper and zinc, from the pXRF readings of drill samples are encouraging. The pXRF equipment cannot be used for reliable readings for gold and cobalt, because of the presence of iron in the samples. The results of the assays for gold, cobalt and base metals from the laboratory may be expected in 2 to 3 weeks’ time.

The RC drilling targeted a 1.5 km exploration area for cobalt, zinc and gold along the western limb of the Stirling Vale Synform.

A total of 1,149 m of RC drilling has been satisfactorily completed (**Figure 2**) with Holes STV001 and STV002 testing the outcropping pyritic siliceous zone (PI2) and Holes STV003 to STV010 testing the “cobaltiferous albite gneiss zone” that was intersected by Pasminco drilling in 1995 and sampled by the Company in 2018 (ASX announcement 17 July 2018).

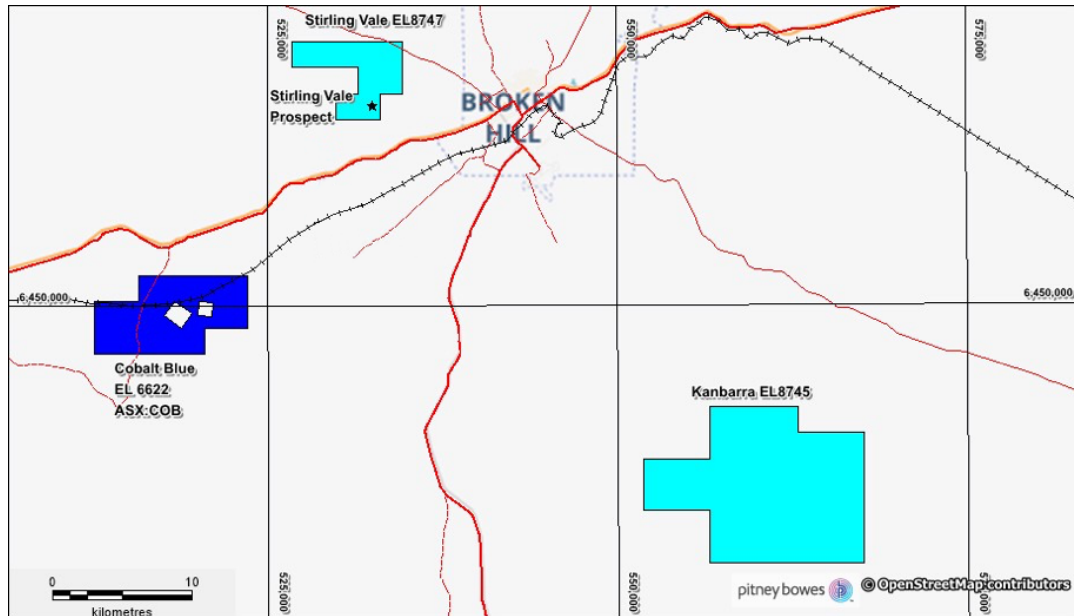


Figure 1: Ausmon Resources Broken Hill Projects

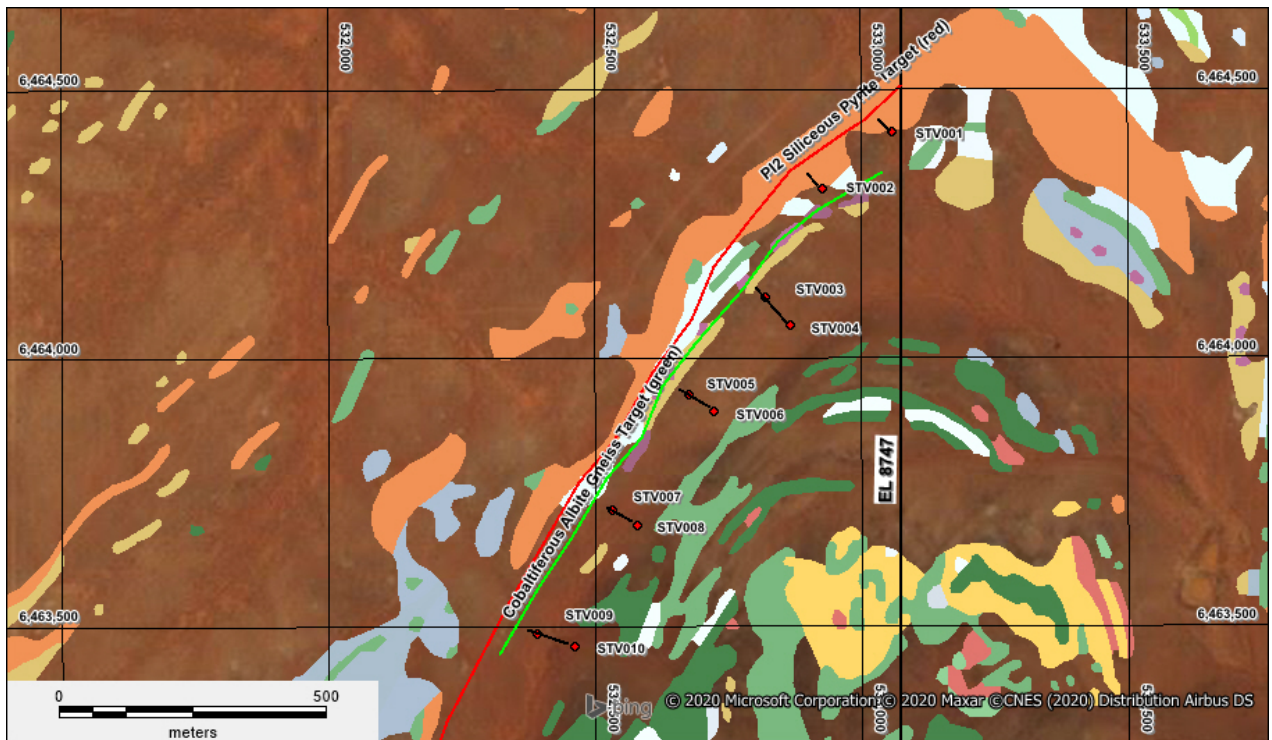


Figure 2: Stirling Vale drill collars STV001 to STV010
