UNDERWRITTEN DIVIDEND REINVESTMENT PLAN

The Board of Glennon Small Companies Limited (ASX: **GC1**) is pleased to announce that it has today issued:

- 208,107 fully paid ordinary shares to shareholders participating in the Dividend Reinvestment Plan (DRP); and
- 1,032,144 fully paid ordinary shares pursuant to the DRP underwriting arrangement announced on 7 October 2020
