UPDATE ON ASSAY RESULTS OF THE 10 HOLES RC DRILLING COMPLETED AT STIRLING VALE EL8747 COBALT-ZINC-GOLD EXPLORATION, BROKEN HILL NSW

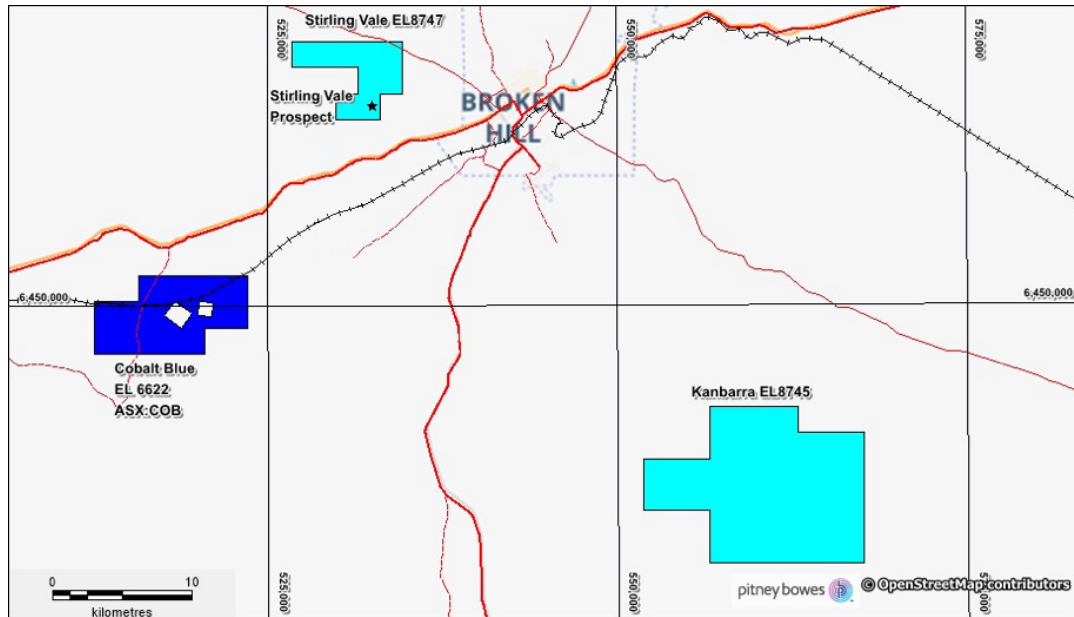


Figure 1: Ausmon Resources Projects near Broken Hill

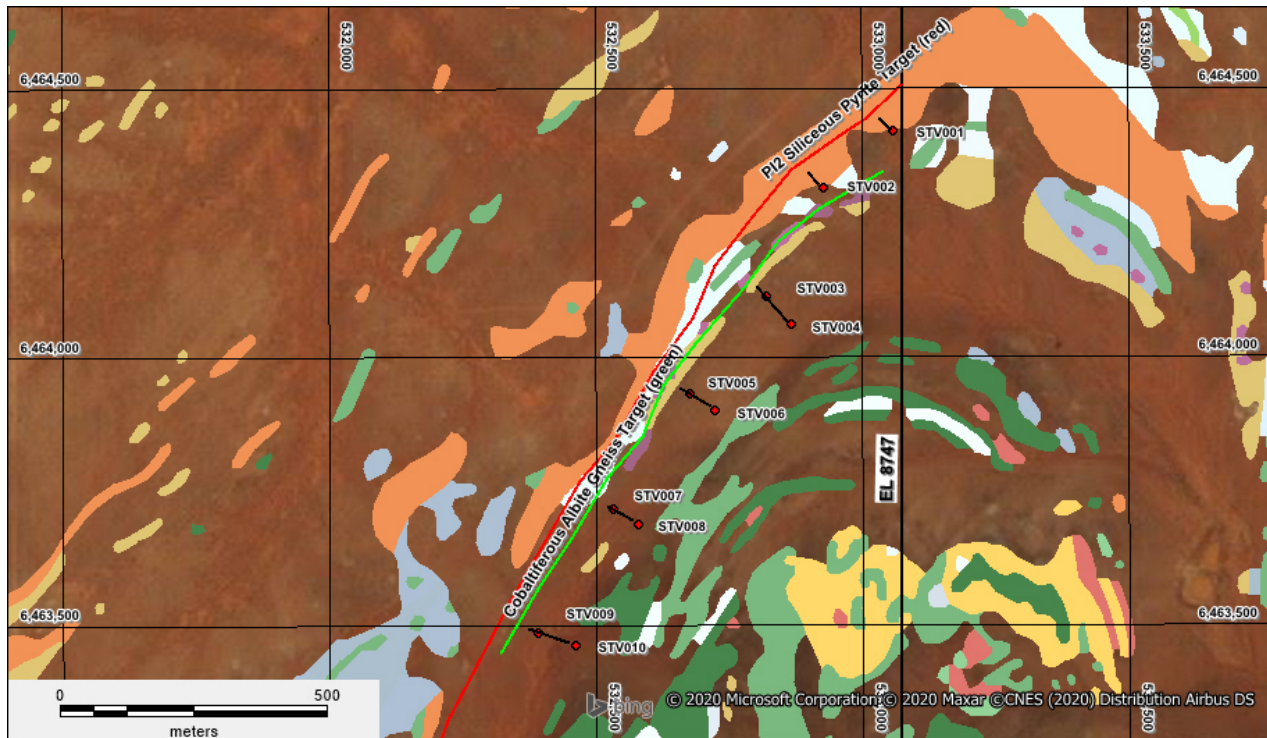


Figure 2: Stirling Vale drill holes STV001 to STV010

Ausmon Resources Limited (“Company”) advises an update on the progress of laboratory analysis of the samples from the 10 holes totaling 1,149 m RC drilling program at Stirling Vale EL 8747 (**Figure 1**) that targeted a 1.5 km exploration area for cobalt, zinc and gold along the western limb of the Stirling Vale Synform (**Figure 2**).

When the drilling was completed in September 2020 the Company expected laboratory results to be available within the usual time frame of 2 - 3 weeks (see ASX announcement of 24 September 2020). The laboratory has advised that they have been subject to very heavy workload, presumably from increased exploration activities by mining companies after the forced slow down during the Covid-19 imposed travel restrictions. Assay results may now be expected at the end of October 2020 with results possibly announced in the first week of November 2020.

In the meantime, the Company is preparing for the RC/Diamond Core drilling program at Nth Kanbarra within EL 8745 near Broken Hill (**Figure 1**) planned to commence in the second half of November 2020, subject to any unforeseen events. That drilling program will test the targets identified from the recently completed Nth Kanbarra Ground IP survey (see ASX announcements of 22 September 2020 and 7 October 2020). The potential from those targets are cobalt, zinc and copper.
