POSITIVE PERFORMANCE OF ANTAM'S GOLD SEGMENT **DURING THE FIRST NINE PERIOD OF 2020**

Jakarta, October 21, 2020 - PT Aneka Tambang Tbk (ANTAM; IDX: ANTM; ASX: ATM) is pleased to announce the positive growth of the Company's operation gold segment during the third quarter period of 2020 (July-September 2020, 3Q20) in midst of positive growth awareness of gold investment amid the upward trend of global gold prices and the volatility of foreign currency exchange rates. During 3Q20, ANTAM's unaudited gold sales volume reached 6,967 Kg (223,994 t oz), significantly increased by 147% compared to gold sales volume in second quarter of 2020 (April-June 2020, 2Q20) amounted to 2,818 Kg (90,600 t oz). For the first nine month period of 2020 (January-September 2020, 9M20), ANTAM's booked the accumulative unaudited gold sales volume of 14,882 Kg (478,467 t oz).

In order to maintain excellent services during the new normal period due to Covid-19 pandemic, ANTAM continues innovation of Logam Mulia gold product marketing services with implemented the online sales transaction and gold buyback. In addition, ANTAM through the Precious Metals Processing and Refinery Business Unit (UBPP LM) has also developed the precious petals gold depository service, called "BRANKAS" to increase the customer's ease of access on safely gold investment in the form of physical gold. UBPP LM is the only gold refining plant in Indonesia with "Good Delivery List Refiner" accreditation from the London Bullion Market Association (LBMA). This accreditation represents the Logam Mulia's product has an international standard that complies with applicable legal principles and safeguards of 99.9% gold content quality.
