**CONTROLLED PLACEMENT AGREEMENT SHARE ISSUE**

**Emerging lithium miner Sayona Mining Limited (ASX:SYA)** announces that it has utilised its Controlled Placement Agreement (“CPA”) with Acuity Capital (as announced on 29 October 2019) to raise \$650,000 (inclusive of costs) by agreeing to issue 68,700,000 SYA shares to Acuity Capital at an issue price of \$0.0095.

The 68.7m shares will be issued out of the Company’s LR7.1A capacity. The issue price of \$0.0095 represents a discount of 2.15% to the 15 trading day VWAP of \$0.0097 to 26 October 2020 (inclusive).

Funds raised will be applied to corporate costs, including the Company's ongoing Quebec and Western Australian activities.
