HIGHLIGHTS

ANTAM's unaudited ferronickel production for the first nine month of 2020 period (9M20) reached 19,133 ton nickel within ferronickel (TNi). Meanwhile, the unaudited ferronickel sales volume amounted to 19,507 TNi.

During 9M20, ANTAM's unaudited nickel ore production which was used as ore feed for ANTAM's ferronickel plant as well as being sold to domestic market amounted to 2.86 million wet metric ton (wmt). The unaudited nickel ore sales booked at 1.21 million wmt.

In 9M20, ANTAM recorded the unaudited gold sales volume of 14,882 kg (478,467 troy oz). The gold unaudited production volume amounted to 1,280 kg (41,152 troy oz). Moreover, ANTAM's unaudited silver production recorded at 9,468 kg (304,403 troy oz) and sold as much as 11,261 kg (362,049 troy oz) of silver during 9M20 (unaudited).

In 9M20, ANTAM's unaudited bauxite production volume, which was used as ore feed for Tayan Chemical Grade Alumina (CGA) plant as well as being sold to the third party customer, amounted at 1.30 million wmt. Meanwhile, the unaudited bauxite sales volume reached 951 thousand wmt.


