1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: Yes, the company does expect to have sufficient funding in the medium term by way of access to current government incentives including the R&D cash rebate, loan funding and capital raisings with regards to proposed Essential Queensland acquisition. We also note that the expenditure of \$506,000 in the September quarter brought various accounts up to date using loan funding provided. Accordingly, the December quarter payments will not be as significant. The company as of 15 October 2020 received the R&D cash rebate of \$278,640 to its bank account.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes, the company has taken steps with several parties to fund its ongoing operations by way of further capital from the Essentials Queensland acquisition. Based on these steps the company believes that it will be successful. Refer to 8.3 Question 1 regarding Essentials Queensland press release.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, the company expects to be able to continue its operations in the medium term based on the steps undertaken at 8.6 Question 2.
