- A claim associated with activities of BIR’s subsidiary Pulse Markets Pty Ltd (“Pulse”) which occurred prior to the acquisition of Pulse by BIR was settled.
- The Notice of the 2020 Annual General was sent to shareholders including an resolution and associated Independent Experts Report for the approval of the Additional \$1 million Convertible Note.


