	<p>Senior Secured Facility: the company has a US\$7.5 million debt facility (US\$6.7m loan availability) with Macquarie Bank Limited which matures in September 2024. The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps.</p> <p>Macquarie and Empire have entered into a waiver agreement or potential breaches of the financial covenants under the debt facility for all quarterly covenant tests until 31 December 2020 (inclusive).</p> <p>Paycheck Protection Program (PPP) loan: the company has a forgivable loan of US\$552,600 under the PPP which can be used for allowable expenses such as payroll over a 24-week period following loan disbursement. The loan has been originated through PNC Bank, carries a fixed interest margin of 1% per annum and matures in June 2022. The PPP loan is unsecured and subordinated to the Senior Secured Facility.</p>
