## ISSUE OF OPTIONS AND EXERCISE OF OPTIONS

BetMakers Technology Group Limited (ASX:BET) ("BetMakers" or the "Company") wishes to advise that today the Company has issued 1,800,000 options ("Options") exercisable into fully paid ordinary shares ("Shares") to employees of the Company under the Company's long term incentive plan ("LTIP"), expiring on 30 September 2023. 1,000,000 Options are exercisable at \$0.45 and 800,000 Options are exercisable at \$0.50.

The Options issued under the LTIP will also be subject to the satisfaction of certain time-based vesting criteria.

BetMakers further advises that it has issued 250,000 Shares upon exercise of that number of Options issued under the LTIP.
