## **Investor Update – October Trading**

## **Highlights:**

- 1,030 new customers added for the month
- Total customers at 31 October 2020 +37% compared to 31 October 2019
- 34,480 total customers with sales momentum improving

Locality Planning Energy Holdings Limited (ASX: LPE) (the Company or LPE) is pleased to provide an update on trading for the month of October 2020.

October was another solid month of consistent customer acquisition growth, with 1,030 customers joining LPE, taking the total customer book to 34,480 at the end of the month. This represents growth of +37% on the prior comparable period (31 October 2019). Approximately one third of residential customers added during the quarter were high-value embedded network customers. This customer segment is central to LPE's core capability, and our customer focused team continues to make inroads in this attractive area of the market where revenues are underpinned by long-term contracts and are therefore highly recurring and durable.

Financial year-to-date the Company has added 3,264 new customers representing an increase of +10.5% since 30-Jun-20, and over 30% of full-year guidance of 10,000 new customers. The Board is pleased with this progress year-to-date and the Company remains firmly on track with regards to the delivery of full-year strategic targets.
