The SimbleHome App allows households to easily analyse and track their energy consumption, helping them to identify opportunities for cost and energy savings. It also incorporates solar generation information and integrates with non-energy related sensors such as humidity and temperature sensors. The SimbleHome App connects with energy IoT devices and is available for Australian residential customers.

Simble has ramped up its commercialisation efforts in recent months. The agreement with HNCD closely follows a deepening of the Company's collaboration with Australian property group Mirvac (ASX: MGR) via a new project Mirvac is building alongside the banks of the Georges Rivers in southwest Sydney. Mirvac will offer the SimbleHome App with associated energy IoT devices to customers of its new Georges Cove Residences.

Simble also continues to invest in improving the SimbleHome App and is currently working on a direct to consumer offer with a buy now pay later payment plan. The Company expects to launch this offer before the end of this month.
