Brambles Limited: Appendix 2A

Please find attached an Appendix 2A relating to 4,735 ordinary shares in Brambles Limited which have been issued as a consequence of the exercise of share awards under the Brambles Limited Performance Share Plan. (Please note that 3,564 unlisted matched share rights granted under the Brambles Limited MyShare Plan and 20,387 unlisted share rights granted under the Brambles Limited Performance Share Plan have lapsed since the lodgement by Brambles of the Appendix 2A on 12 November 2020.)
