Further Update on SkyCity Adelaide

SkyCity Entertainment Group Limited (SKC.NZX/SKC.AX) ("**SkyCity**") advises that it expects to reopen its Adelaide casino and entertainment facilities from 9.00am (ACDT) on 22 November 2020 following the announcement by the South Australian Government earlier today lifting certain COVID-19 restrictions implemented earlier in the week in response to a new COVID-19 cluster in Adelaide.

SkyCity Adelaide is expected to reopen from 9.00am (ACDT) on 22 November 2020 with physical distancing and hygiene requirements in place consistent with the approach adopted previously, including:

- initially limiting casino entry to certain SkyCity Premier Rewards membership tiers only;
- capacity subject to a maximum patronage of one person per four square metres and a maximum capacity of 100 people (in addition to staff) within the gaming area and each food and beverage outlet at any one time;
- adherence to strict physical distancing measures, including configuring electronic gaming machines to allow appropriate physical distancing, limiting customers at each gaming table and ensuring appropriate spacing when dining;
- infrastructure established to support contact tracing, primarily through surveillance, quest registers, identity scanning and use of loyalty cards; and
- enhanced hygiene protocols.

SkyCity will provide further updates as new material information becomes available.
