Shareholders are reminded that the Archer Materials Limited ("Archer", the "Company", "ASX: AXE") Annual General Meeting ("AGM") will be held next Monday (30 November 2020) at 10:00am (Sydney time). The AGM will be held virtually meaning that you will need to login to the appropriate website to be able to participate in the AGM. You will not be able to physically attend the AGM in person.

You need to be registered as an Archer shareholder at 7.00pm (Sydney time) on Saturday, 28 November 2020 ("Shareholder") to be able to ask questions and vote in real-time at the AGM. Non-Shareholders may view the AGM but cannot vote or ask questions.
