Details of acquisition of a relevant interest in voting securities of the Reef Casino Trust (RCT Units)

- ÖBAG has entered into a Shareholder's Agreement with SAZKA Group a.s. (ÖBAG/SAZKA Shareholders' Agreement) to govern the management of Casinos Austria AG (CASAG). Amongst other things, the ÖBAG/SAZKA Shareholders' Agreement provides ÖBAG with rights over certain decisions regarding CASAG's operation including matters relating to financial and operating policies of CASAG (Control Provisions). The Control Provisions became effective on 25 November 2020.
- 2. As stated in CASAG's most recently lodged Form 604 dated 6 June 2012, CASAG has a relevant interest in 67.1% of the RCT Units.
- 3. As a result of the Control Provisions, ÖBAG and its associates are deemed to have acquired the same relevant interest in RCT Units as currently held by CASAG (being 67.1%) by virtue of section 608(3)(b) of the *Corporations Act 2001* (Cth) (Corporations Act) (Downstream Acquisition).
- 4. ÖBAG has obtained an exemption from ASIC pursuant to ASIC Instrument 20-0792 which exempts it from having to comply with section 606 of the Corporations Act in respect of the Downstream Acquisition, subject to the conditions set out in that ASIC Instrument.
- 5. No consideration was payable for the Control Provisions other than the mutual promises provided in the ÖBAG/SAZKA Shareholders' Agreement.
