## Ansarada Group Limited – (ASX: AND) – Anticipated Reinstatement to Official Quotation

### Description

The securities of Ansarada Group Limited ('AND') (formerly thedocyard Limited (ASX:TDY)) are expected to be reinstated to Official Quotation at the commencement of trading at 10:00 am AEDT on Wednesday, 9 December 2020, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. AND raised \$45 million pursuant to the offer under its prospectus dated 30 October 2020 ('Prospectus') by the issue of 30,405,406 shares at an issue price of \$1.48 per share.

TDY will be renamed Ansarada Group Limited and trade under ASX code "AND" on reinstatement.
