## ISSUE OF OPTIONS AND EXERCISE OF OPTIONS

BetMakers Technology Group Limited (ASX:BET) ("BetMakers" or the "Company") wishes to advise that today the Company has issued 250,000 unlisted options ("Options") exercisable into fully paid ordinary shares ("Shares") to an employee of the Company under the Company's long term incentive plan ("LTIP"), expiring on 31 October 2023 and exercisable at \$0.50 per Option.

The Options issued under the LTIP will also be subject to the satisfaction of certain time-based vesting criteria.
