Notice under Section 708A(5)(E) of the Corporations Act 2001 (Cth)

Sydney, Australia – Aumake Limited (**ASX: AUK**, **Aumake**, or the **Company**), operator of an online platform that connects Asian influencers with high-quality and authentic Australian brands, has today issued 104,075,580 Ordinary Shares (New Shares) as per the Appendix 2A lodged earlier today.
