Meeting

Simavita is a Canadian incorporated company and is permitted under the Business Corporations Act (British Columbia) and Simavita's articles to hold its meetings using technology. Given the current requirements for social distancing, travel restrictions and restrictions on public gatherings, the Board feels that holding the Meeting by webcast is the most appropriate way to conduct the meeting. In order to comply with social distancing requirements, we strongly recommend that CDI holders not attend the offices of K&L Gates in Sydney.

As a Canadian company with CHESS Depositary Interests ('**CDIs**") listed on the ASX, Simavita has only one shareholder who is entitled to vote at shareholder meetings and that is CHESS Depositary Nominees Pty Ltd, a wholly owned subsidiary of the ASX, who legally holds the shares on behalf of CDI holders. CDI holders hold the beneficial ownership of the shares. As part of the webcast, CDI holders will have the opportunity to ask questions, as is the case at meetings held in person, however votes will need to have been lodged prior to the meeting as per the usual requirements for CDI holders, as set out below.

Voting

Copies of the Notice of Special Meeting, Management Information Circular and CDI voting instruction forms (collectively, the "Meeting Materials") have been sent to all security holders and are also available on SEDAR and on the Company's website at <u>www.simavita.com</u>.

This is an important meeting for Simavita and we encourage all securityholders to review the Meeting Materials and vote by following the instructions on their CDI voting instruction form that they have received.

CDI holders should vote by completing a CDI Voting Instruction Form and lodging it with the registry, Computershare, not later than **Monday 18 January 2021 at 11.00am Australian Eastern Daylight time.** No votes will be accepted after this time or at the Meeting.
