## CD Private Equity Fund III (Fund) ASX: CD3 NTA & Fund Update – 31 December 2020

## NTA Update

The estimated unaudited net tangible asset (NTA) value after tax as at 31 December 2020 was \$1.88<sup>12</sup> per unit (30 November 2020 was \$1.99<sup>2</sup> per unit).

Between 30 November and 31 December 2020, the majority of the change in the estimated unaudited NTA can be attributed to foreign exchange movements. During the period, the Australian dollar appreciated against the US dollar by 4.77% to 0.7694 (from 0.7344 in November 2020).

## Capital Called

At 31 December 2020, US Select Private Opportunities Fund III L.P. (LP) has called US\$98.5 million (or 86.4% of capital committed). The Fund's proportionate share is approximately US\$70.2 million (a 71.2% share).
