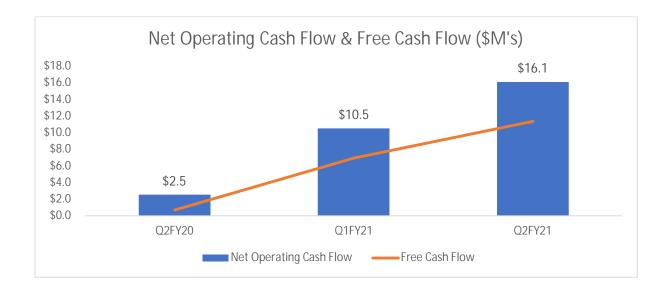

# OPERATIONAL UPDATE & FINAL APPENDIX 4C (Q2-FY21) Operating Cash Flow up 53% on prior quarter. Free Cash Flow up 64% on prior quarter.

- Record Net Operating Cash Flow of \$16.1M, up 53% on prior quarter (Q1-FY21)
- 544% increase in Net Operating Cash Flow vs prior corresponding period (Q2-FY20)
- Record Free Cash Flow in Q2 of \$11.3M, up 64% on prior quarter (Q1-FY21)
- Free Cash Flow represents 70% of Net Operating Cashflow, after all capex
- Key financial performance metrics for first half of FY21 above forecast levels
- Materially above-forecast growth in net new FTTP activations in the quarter
- Completed OptiComm, HarbourISP and Telstra Velocity® acquisitions in the quarter

**27 January 2021:** Uniti Group Limited (ASX: UWL) ("UWL", "Uniti", "Company") is pleased to provide an overview of its December quarter (Q2-FY21) cash flow and cash position, as reflected in the Appendix 4C that accompanies this announcement, including a summary of the key elements of the record Net Operating Cash Flow and Free Cash Flow performance of the Company delivered in Q2-FY21.

The chart below highlights the continuing transformation in Net Operating Cash Flow and Free Cash Flow (Net Operating Cash less Capital Expenditure) performance over the last 12 months, most notably a 544% increase in Net Operating Cash since the prior corresponding period (Q2-FY20), together with a step-change in both Net Operating Cash Flow and Free Cash Flow in the December 2020 quarter compared to the prior quarter (Q1 - September 2020), up 53% and 64% respectively.







Notably, the Q2-FY21 quarter was the first quarter in which Uniti has begun to pay income tax, having utilised all previously accumulated tax losses. This (net of a once-off dividend received in the quarter of approximately  $\$0.6M^1$ ) represented an approximate \$2M reduction to reported Net Operating Cash in Q2-FY21, further illustrating the scale of the quarter-on-quarter growth in positive operating cash flow, as the 53% increase in Net Operating Cash is calculated after the impact of this income tax payment.

Adjusting Net Operating Cash Flow of \$16.1M for the one-off income tax cash payment and receipt of the OptiComm dividend, Net Operating Cash Flow is greater than \$18M in Q2-FY21, a greater than 70% increase on the prior quarter.

Furthermore, Q2-FY21 included only 2 months earnings contribution from HarbourISP, 1 month from OptiComm, and 1 week from the Telstra Velocity® assets, with expectations of further strong growth in Net Operating Cash Flow and Free Cash Flow in the coming periods, when the earnings contributions from these accretive acquisitions are recognized for the full reporting period, and accompanying synergies are realised.

Uniti Managing Director and CEO, Michael Simmons, said of Uniti's performance in Q2-FY21:

"What a remarkable quarter it was for Uniti Group, having finally secured the OptiComm business together with the HarbourISP business and the Telstra Velocity® assets, cementing Uniti's position as Australia's largest private owner-operator of greenfield FTTP networks & the pre-eminent challenger in greenfield FTTP markets. In addition to these transformative acquisitions, our exceptional Uniti team continued to deliver in terms of operating performance, evidenced by the 53% jump in Net Operating Cash over the prior quarter (and more than 70%, if adjusted for one off tax payments and dividend receipt in Q2), with only a part period contribution from our most recent acquisitions, which bodes very well for further material expansion in both Net Operating Cash Flow and Free Cash Flow over coming period.

With our two-year anniversary of ASX listing looming next month, the team at Uniti is most proud of the highly cash generative, privileged infrastructure business we have built over this time. Notwithstanding our continued investment in expanding our owned fibre infrastructure assets, we are generating in excess of 60% of our EBITDA as surplus cash after funding all capital expenditure."

### **Operational Performance Highlights**

- Record Net Operating Cash Flow of \$16.1M in the December quarter, up 53% on prior quarter and more than 70% if one off tax payments and dividend receipts are adjusted.
- Record Free Cash Flow (Net Operating Cash Flow less Capital Expenditure) delivered of \$11.3M, representing 70% of Net Operating Cash Flow, illustrating the strong cash generation credentials of UWL's three business units (or 'pillars'). This represents a 64% uplift in Free Cash Flow on the prior quarter.
- These record Net Operating Cash Flow and Free Cash Flow results in the December quarter reflect only part period contributions from OptiComm (1 month), HarbourISP (2 months) and Telstra Velocity® assets (1 week).
- Growth-related capital expenditure in Wholesale and Infrastructure ("W&I") business unit was \$4.2M, predominantly attributable to the deployment of additional Fibre-to-the-Premises ("FTTP") connections in newly completed developments, in which Uniti is the exclusive FTTP network operator.

- New FTTP connections constructed for the December quarter was ~5,300.
- OptiComm and HarbourISP acquisitions both performing above management's expectations to date.
- Strong Net Operating Cash Flow performance of the Company during the December quarter is supported by considerable growth on prior periods in all key Uniti Group operating metrics, notably revenue, gross margin, EBITDA, working capital and cash generation.
- OptiComm, HarbourISP and Telstra Velocity® assets acquisitions completed during the quarter. Uniti transformed into a large-scale "core-plus" infrastructure company, with 76% of Uniti's proforma FY21 EBITDA forecast to be generated by delivering services over its owned fibre infrastructure networks.
- W&I business unit again exceeded forecasted levels in terms of active service growth and earnings. "OptiComm" brand adopted as customer-facing brand for W&I.
- Consumer & Business (C&B) business unit delivered record net growth in new retail subscribers during the December quarter, benefiting from the additional scale and distribution reach brought by the acquisition of HarbourISP.
- Specialty Services / Platform-as-a-Service ("PaaS") business unit secured several large corporate and wholesale customer contracts in the quarter and continued the strong organic growth in its PaaS offerings and earnings on prior periods in Q2-FY21, in both its premium inbound (13/1300/1800) and SMS delivery platform services.
- Uniti ended the December quarter with \$45M in cash and net leverage of ~2.2 times proforma FY21 EBITDA of \$116M, excluding a further \$20M proceeds from the significantly over-subscribed Share Purchase Plan (SPP) received during January 2021. Net leverage reduces to ~2 times proforma FY21 EBITDA with the receipt of the SPP funds.

### Uniti's Final Appendix 4C

In accordance with its obligations under the ASX Listing Rules, Uniti has released an Appendix 4C for each of the 8 quarters since its listing in February 2019. Uniti will no longer be required to provide a quarterly financial report to the market. Uniti's half year and full year financial reporting obligations will remain unaltered, each containing detailed cash flow reporting together with all other key financial reporting, governance statements and operational performance updates.
