COMPLETION OF SHARE PURCHASE PLAN

BetMakers Technology Group Limited ("**BetMakers**" or "**the Company**") (ASX:BET) confirms the completion of the issue and allotment of the new fully paid ordinary shares ("**SPP Shares**") under the share purchase plan ("**SPP**").

Further to the announcement dated 20 January 2021, BetMakers has today issued to SPP participants approximately 16.66 million SPP Shares at \$0.60 per SPP Shares (being the same issue price as the institutional placement announced to ASX on 2 December 2020 ("**Placement**")) to raise approximately A\$10 million bringing the total gross proceeds raised pursuant to the Placement and the SPP to A\$60 million (before costs).

An Appendix 2A in respect of the SPP Shares was released to the market yesterday and a Cleansing Statement is set out below.

Unless otherwise defined, capitalised words in this announcement have the same meaning given to them in the SPP Offer Booklet.

Issue of Shares on exercise of Options

Separately, BetMakers wishes to advise that it has issued 628,846 fully paid ordinary shares ("**Shares**") upon exercise of 675,000 Options issued under the Company's long term incentive plan ("**LTIP**").

An Appendix 2A in relation to the quotation of Shares is attached.

The Company advises that it is not required to issue a cleansing statement under section 708A(5)(e) of the *Corporations Act 2001* (Cth) ("**Act**") on the basis that the Options were issued under the LTIP in accordance with the relief provided under ASIC Class Order [CO14/1000].
