HIGHLIGHTS

In 2020 (FY20), ANTAM recorded all time high ferronickel production volume. ANTAM's unaudited ferronickel production reached 25,970 ton nickel within ferronickel (TNi). Meanwhile, the unaudited ferronickel sales volume amounted to 26,163 TNi.

During FY20, ANTAM's unaudited nickel ore production which was used as ore feed for ANTAM's ferronickel plant as well as being sold to domestic market amounted to 4.76 million wet metric ton (wmt) with unaudited nickel ore sales booked at 3.30 million wmt.

ANTAM Focus to Develop the Domestic Gold Customer Based. In FY20, ANTAM record unaudited gold sales figure of 21,797 kg (700,789 troy oz) with unaudited production volume amounted to 1.672 kg (53.756 troy oz).

In FY20, ANTAM's unaudited bauxite production volume, which was used as ore feed for alumina production and as well as being sold to the third party customer, amounted at 1.55 million wmt.

Meanwhile, the unaudited bauxite sales volume in FY20 reached 1.23 million wmt.


