E&P Investments Limited (**E&P Investments**), as the Responsible Entity for the New Energy Solar Fund (**Trust**), and New Energy Solar Limited (**Company**), together **New Energy Solar**, the **Business** or **NEW** are pleased to announce a distribution of 3.00 cents per stapled security for the six-month period ended 31 December 2020.

The record date for determining entitlement to the distribution will be 5 February 2021 (**Record Date**). The intended payment date for this distribution is expected to be on, or around, 19 March 2021.

The next distribution is scheduled for the six-month period ended 30 June 2021.

Distribution Reinvestment Plan (DRP)

NEW will operate a DRP for the 31 December 2020 distribution under which stapled securityholders may elect to have all, or part, of their distribution payment reinvested in new stapled securities.

The reinvestment price will be calculated using the arithmetic average of the daily volume weighted average market price per NEW stapled security during the ten trading days commencing on the trading day following the Record Date. The ten-trading day period for the 31 December 2020 distribution will commence on 8 February 2021.

If NEW's stapled securities do not trade on a minimum of five days during the ten-trading day period, the reinvestment price will be:

- the most recently announced net asset value (NAV) per stapled security, before provision for tax, available at 7pm on the last trading day of the ten-trading day period; or
- such other price as may be determined by the NEW Directors in accordance with NEW's constitutions.

The last day for NEW stapled securityholders to elect to participate in or withdraw from the DRP in respect of this distribution is 5pm (Australian Eastern Daylight Time) on 26 February 2021.
