CardieX Announces ESOP Options to Key Employees

CardieX Limited (ASX: CDX) (CardieX, the Company) announces today, in conjunction with the appended Appendix 3G, key terms of its Performance Rights and Options Plan (Plan) as approved by shareholders on 11 December 2020, options provided to key employees as part of its policy to recognise employee contributions of service and performance.

Terms of the Offer made to key employees are detailed below:

- (a) Subject to the following, the Company is offering key employees the following Awards on a cumulative basis to all staff under the Plan, with the following Option Exercise Price and Expiry Date, and subject to the following Vesting Conditions which apply to each offer made to each respective key employee:

- (b) The grant of the Awards is subject to the terms and conditions of the Plan, including the Company obtaining any necessary Shareholder approvals and the employee remaining an Eligible Participant at the time the Awards are to be granted and (subject to a number of exceptions), exercised and converted into Shares.
- (c) The Company will issue, where required to enable Shares issued on exercise of Awards to be freely tradeable on the ASX (subject to any Restriction Period), a cleansing statement under Section 708A(5) of the Corporations Act at the time Shares are issued. Where a cleansing statement is required, but cannot be issued, the Company will have a prospectus available in relation to the Shares which complies with the requirements of the Corporations Act.
