# NEW ENERGY SOLAR (ASX: NEW) UNAUDITED NET ASSET VALUE AS AT 12 FEBRUARY 2021

New Energy Solar's<sup>1</sup> weekly estimated unaudited net asset value (**NAV**) as at 12 February 2021 was A\$1.18 per stapled security.

New Energy Solar's directors have elected to make this disclosure to the market to provide securityholders with additional information about changes in the estimated NAV of their stapled securities due to movements in the AUD:USD foreign exchange rate.

This weekly unaudited NAV estimate has been calculated by reference to New Energy Solar's most recently published audited NAV (being A\$1.32 per stapled security as at 30 June 2020 which applied an AUD:USD foreign exchange rate of 0.6903), adjusting for changes in the AUD:USD foreign exchange rate and the number of stapled securities on issue since that date. The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 12 February 2021 was 0.7761.

Securityholders should note that New Energy Solar's stapled securities have traded on an ex-distribution basis since 4 February 2021 in relation to the 3.00c distribution per stapled security announced on 1 February 2021.

New Energy Solar is in the process of reviewing and updating the fair value of its investments as part of the 2020 annual financial report to be released in February 2021. Accordingly, NEW's unaudited NAV estimate noted above does not take into account any potential changes to the value of New Energy Solar's investments that might arise from the revaluation exercise.
