(GFI) (through certain wholly owned subsidiaries) has entered into an underwriting agreement (Sale Agreement) in relation to the sale of all of GFI's shares in the Company (constituting approximately 52% of the issued shares of the Company).

On completion of the sale pursuant to the Sale Agreement, GFI will no longer own any shares in the issued capital of the Company.
