

CANNINDAH RAISES \$1 MILLION TO ADVANCE EXPLORATION AT PICCADILLY

Cannindah Resources Limited is very pleased to announce that it has raised \$1,000,280 through the issue of 20,400,000 shares in a placement managed by 180 Markets.

Funds received from the capital raising will be used to advance drilling and other exploration activities at the Piccadilly project, meet working capital needs and the costs of the issue. The work will initially focus on drill targets determined by the trench sampling to be conducted in ML 1442 as highlighted in our ASX announcement of 2 March 2021.
