Genworth Mortgage Insurance Australia Limited (ASX:GMA) Appendices 3Y and 3Z

We attach an Appendix 3Y and Appendix 3Z for Stuart Take and an Appendix 3Z for Rajinder Singh.

In relation to the Appendix 3Y (Change of Director's Interest Notice) for Mr Take, while his interest in securities of Genworth remains unchanged, there was a change in his interest in securities of Genworth Financial, Inc. (GFI), which at the time of the change was a related body corporate of the Company. We note that as GFI is no longer a related party of the Company, any change in Genworth directors' interests in securities of GFI will no longer be notifiable under Listing Rule 3.19A.

The Appendix 3Y is being lodged late due to an administrative oversight and the need to confirm details of security holdings and transactions that occurred in securities of Genworth Financial, Inc. The Appendices 3Z are being lodged within the prescribed timeframe.

In accordance with Listing Rule 3.19B, Genworth has agreements with each of its Directors to ensure that it is able to meet its disclosure obligations under Listing Rule 3.19A. The agreements contain substantially similar provisions to those in Attachment 1 of ASX Guidance Note 22: *Director Disclosure of Interests and Transactions in Securities – Obligations of Listed Entities*.

We do not consider that any additional steps are necessary for the Company to ensure compliance with Listing Rule 3.19B, although we will remind Directors of the importance of accurate and timely notification of their notifiable interests.
