## CHALLENGER APPOINTS CHIEF EXECUTIVE LIFE

Following these executive changes, Mr Anton Kapel will resume his previous role as Challenger's Appointed Actuary and Chief Financial Officer of the Life business. Mr Howes thanked Mr Kapel for his contribution as Acting Chief Executive for the Life business.

These changes will take effect on 15 March 2020.
