CLEANSING NOTICE UNDER SECTIONS 708A(5)(e) AND 1012DA(5)(e) OF THE CORPORATIONS ACT

This cleansing notice (**Cleansing Notice**) is given by Eildon Capital Limited ACN 059 092 198 (the **Company**) and Eildon Funds Management Limited ACN 066 092 028 (the **Manager**) in its capacity as responsible entity for Eildon Capital Trust ARSN 635 077 753 (the **Trust**) under sections 708A(5)(e) and 1012DA(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).
