## **ACUMENTIS COMPLETES THE ACQUISITION OF SAUNDERS & PITT**

The completion of the acquisition included:

- Payment of \$150,000 cash consideration reduced by \$42,968 relating to employee leave liabilities transferred to Acumentis; and
- The issue of 3,244,120 ordinary shares at a price of 12.33 cents (based on the VWAP for the three weeks up to 15 March 2021).
