ACTIVITIES REPORT AND APPENDIX 4C – QUARTERLY CASH FLOW REPORT MARCH 2021

Adelaide, Australia, Tuesday 13 April 2021: Axiom Properties Limited (ASX:AXI) lodges the attached Appendix 4C Quarterly report for entities admitted on the basis of commitments for the quarter ended 31 March 2021.

The Company's cash reserves for the December quarter increased by \$3.394 million and the Company held cash reserves of \$23.271 million as at 31 March 2021.

Details of the Company's business activities for the quarter are as follows:

- o Majority of development costs spent were on the construction of the South Australian Emergency Services State Command Centre and multi-deck carpark, being \$7.512 million. Charter Hall as the landowner is funding all development costs ongoing monthly as costs are approved by the independent certifier, totalling \$10.684 million for the quarter.

The balance of net operating cash flows for the March quarter included cash out flows of employee, office overhead and interest costs as disclosed in item 1 in the below 4C, which are representative of regular quarterly operating costs.

- o During the quarter the Company received \$0.026 million in distributions from its investment in Churchill North Centre Investment Trust 1 and sold 1,180,000 units of its units in the Churchill North Centre Investment Trust 1 at \$1 per unit. The sale of these units represented the balance of units held in the trust and as such the Company no longer holds any units in the investment.
- o Net financing cash outflows for the March quarter were \$0.053 million relating to right of use lease liability of the Adelaide and Sydney offices and motor vehicle.
- o Aggregate amount of payments to related parties and their associates are for director fees and salaries and wages, as well as for costs incurred on behalf of the Company in the ordinary course of business, which were reimbursed at cost.

The Board refers to its announcement on 19 March 2021 advising of shareholder approval to pay a return of capital to shareholders and advises that this was paid on 9 April 2021. The total amount paid to shareholders of \$6,490,705.16 will therefore be included in the June quarter cashflow.

The Board and its executives continue to monitor operating and overhead costs to ensure the Company remains in a strong financial position. There were no substantive changes to business activities during the quarter.
