ASX Code: URF US Masters Residential Property Fund (Fund) Net Asset Value as at 9 April 2021

The weekly estimated unaudited net asset value (NAV) before withholding tax as at 9 April 2021 was \$0.64* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 9 April 2021 would be \$0.53* per unit.

Calculation of weekly NAV

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited monthly NAV at 31 March 2021 (being \$0.64 per unit on a pre-tax basis and \$0.53 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.7598), adjusting for changes in the AUD:USD foreign exchange rate.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 9 April 2021 was 0.7623.

These weekly estimates do not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.
